Report of the Superintendent

II. Report of the Superintendent

- The Sound Waves from Long Beach High School will be performing at Jones Beach on December 17 from 6:30 7 PM and on December 21 Long Beach Middle School singers will be performing. Tickets are required; \$3 discount with code.
- Mr. DeVito presented a budget update: the district should be receiving a large PILOT from LIPA which will have a minor impact on the community.
- Presentation District Special Education Presenters: Sabrina Cantore, Vicki Batkin, Kim Ligouri, Vincent Russo

Highlights include: Pupil Personnel Services, Guiding Principles, Continuum of Services, Programs, Staff, and Teaching Assistants/Aides by Building, Other District PPS Staff, Data Snapshots, Student Statistics, and On-Going Initiatives. Presentation can be located on the district website or in the office of the District Clerk.

III. Student Organization Announcements

Student Announcements

- Alana Weiss the Student Organization is excited about their first winter formal, dance for upperclassmen in January; SO officers and others are attending a leadership conference in January for Relay for Life (May); Class Olympics are in February; main event for the club.
- Samara Benny and Jordan Teemer LBHS Seniors and Co-Presidents, LB African American Culture Club – Diamond Lambert, VP – submitted proposal for African American studies course; garnered 100 signatures on petition; met with Mr. Hurley and Mr. Stroud; teachers were interested in teaching the course; should be introduced as an elective for seniors who are not in IB, AP, SUPA classes; substitute for government or economic credit; only 2 options currently; top HS administrative are supportive but there is a need to include other culture classes as well – it could be done.

IV. President Lester called for Board of Education Comments

Board of Education Comments

 Board Member Ryan thanked the presenters; asked that this topic be discussed at budget time; questioned the hiring of staff during the school year (CSE recommendations are done February – May; inconsistent with budget process).

Board of Education Comments (continued)

- Dr. Ryan asked why Lido school had significantly fewer special ed students (ENL class was going to be placed there); questioned special ed students working in the public library (home instruction students, work based program); how Title 1 services are determined (AIS elementary services fragmented unlike MS & HS); asked if it paid to take students from out of district fiscally responsible (unsure); explained that our teaching model is expensive but we should be commended for it; voiced concern about the lack of special ed students at Lido.
- Board Member Tangney questioned the CPSE process for the 59 students (15 center based students; remainder at therapy rooms of certified therapists; no home services; nursery/Pre-K programs); asked if there was a problem with therapists at Blackheath (therapists caseloads are full); asked what happens when you hit a wall (work with families/therapists to modify schedule, call County to find providers).
- Vice President Mininsky asked how many students come into the district (6 tuition students; last year it was 13); if TAs got training (no general training; in class training)
- Board Member Vrona thanked the presenters; asked about diploma pathways, safety net (can be located on website HS counseling center link SE graduation opportunities Career Development Opportunity Studies (CDOS) and Alternative Assessment no diploma credential); asked about students who cannot score 65 on four Regents exams (no option but 55 pass on one exam in emergency local diploma disappeared); safety net of 55 has disappeared.
- Dr. Ryan asked if BOCES was keeping up with student needs (offers different programs; emotional needs are exhausted; are responsive).

V. President Lester called for Questions and Comments from the Public – Items on Tonight's Agenda Only

Questions and Comments from the Public – Items on Tonight's Agenda Only

- Keith Harvey CTA President questioned the Budget Advisory Committee guidelines and goals for this year, who the chairperson is (Steve Candon) and whether there was a policy (yes).
- Alexis Pace 660 E. Olive Street respectively disagrees about inclusion program; program could be a lot stronger; no full time TAs so student's day is fragmented ½ day TA in AM and ½ day TA in PM across all special ed classrooms; especially problematic in the inclusion/collaborative classroom where there is a special ed teacher for 4 periods per day; not always a good fit because it does not provide enough support; some programs have full day special ed teachers which is more supportive.
- Kerrie DeStefano 30 Alabama Street, Patrice Krzeminski 557 E. Market Street SEPTA Co-Presidents thank you for your efforts with the Special Ed programs in LB; SEPTA advocates for all special needs children and their families; speaking on behalf of all children as well as our non-verbal students; SEPTA has been contacted by several parents, educators and community members regarding allegations that have been brought to light by social media and private mailings; we hope the district is looking into these allegations and conducting a proper investigation; SEPTA has been accused of non-action but SEPTA was unaware until this school year; since then they have attended numerous meetings with administration; they trust the process that the district has been legally advised to take; we will do whatever we can as a PTA; asked for transparency; requested a statement from the administration.

Questions and Comments from the Public (continued)

- Gerri Maquet and Andrea Wayne CCPTA Co-Presidents reiterated SEPTA comments; CCPTA stands with them, hoping that all due process is being done, all the right procedures being followed; have utmost respect for BOE and SEPTA; we are here to support them.
- Vicki Lyons 19 Vinton Street –she and her husband are parents of a child with a significant disability and a typically developing child; we no longer feel confident that our children are safe at school; begged BOE and administration to make sure schools are safe for all children especially for those who cannot defend themselves; one final thought a glimpse of what a parent of a special needs child struggles with daily– ever since my son was diagnosed at the age of 3, the only thing I ever wish for is just to live one day longer than my Dante, so that I can protect him and keep him safe.
- John Gilmore 550 E Chester St asked why we no longer have 6:1:2 classes for the
 most severely affected children, self-contained classes (heard that there are less
 affected children than there used to be); would like to see verifiable data; issue of
 children being placed in a timely manner, appropriate setting (knows of at least one
 case); was told his child was not a victim but has heard otherwise; issue needs to be
 resolved with least amount of damage to district.
- Joy McCarthy 28 Wyoming Avenue my oldest 2 of 4 were very active in the special ed community hit every level on screen presentation over 20 years; very difficult because I have had positive experiences in special ed but this situation is terrible; parents may be put in adversarial position from the get-go; if you don't know what you are entitled to, like a parent member, you don't know what to ask; stressful situation; confines of the money; district tries to make it not about the money, but it is; her son was a guinea pig, kept moving around district; must have an understanding of parental concerns.
- James Hodge 95 E. Fulton Street have had some great experiences with Special Ed and other times; people come here to speak so let them do so, let counsel cut them off; asked how many of the 50 special education teachers are African-American; some children replicate what they see; not one African-American teacher in the HS or MS (maybe one); will an African American have to be on the school board before you hear African American concerns; students came up with a petition, have been trying for two years; be careful that children are being classified as disabled when there is simply a behavior problem; behavior plan works with some of those children; continue to try to have outside advocates at those (CSE/CPSE) meetings which are very intimidating; black college fair bus.
- Joanne Rea 90 Connecticut Avenue disturbed by special ed children
 presentation; children being short changed by district hiring 156 PT TAs as opposed
 to 15 FT when consistency is of the utmost importance to special ed children; better
 fiscally for district to not pay benefits; for some employees day starts and begins with
 these children; let's not lose sight of our focus on the children.
- Hope Orner 327 W. Olive St asked about availability of parent training for a child who is currently home receiving 1½ to 2 hours per week of instruction awaiting placement.
- Michelle Fitzpatrick 416 W. Penn Street parent of MS Down syndrome student who receives services; in elementary and HS there is integration; MS needs something better; many students would benefit from electives (integrated classes).

- Chrystle Agee 90 E. Market St BOCES TA applauds the four students who
 presented the proposal for the African American Club; only topics covered in
 classes are basics; MLK fought for all rights; cultural diversity classes would be
 beneficial.
- Kathleen Casey 650 W. Chester St for past 2 BOE meetings, special ed parents have been coming to podium; asked if the BOE is investigating allegations.
- Kim Greengus 47 Boyd Street has 4 children in district; one was in the MS class for three years; next conversation will be with her attorney.
- Heidi Weitz 85 Blackheath Road asked if every school employee who works in a school building is mandated to report abuse (certificated staff, administrator, BOE members must report within a day to proper administrator, gather facts, technical info, reasonable suspicion, determine outcome, done with district labor counsel); if something was never reported, what is the obligation of the district; voiced concerns after hearing public comments.
- Vivian Lambert 253 E. Hudson supports African American class; there is a lot more to learn; black vernacular viewed negatively.
- Rachel Richter 122 Wilson Ave when allegations are made what is the process; where are we in the process (first call is to attorney, interviews, decided whether a report is to be made; parents are informed).
