President Posterli called the meeting to order at 7:10 PM and led the community in the Pledge of Allegiance. Ms. Posterli welcomed everyone and praised the High School production of Pippin and the Middle School Science Symposium.

II. Superintendent's Report – Dr. Gallagher

Dr. Gallagher turned the meeting over to Michael DeVito for the Budget Presentation on Benefits, Debt Service, Legal and Insurance.

Michael DeVito presented the 2021-22 Budget Presentation on Benefits, Debt Service, Legal and Insurance. Highlights include in Benefits, State Retirement, Teachers Retirement, Disability Insurance and Medical Insurance; Serial Bonds and Other Debt Service; Legal Services, including district general counsel, labor counsel, construction counsel and hearing officer; Unallocated Insurance and Workers' Compensation, which is comprised of actual claims paid, 3rd party administrator fee and premiums for excess workers' comp; Transfer to Other Funds, including Transfer to Capital for Transportation, Transfer to Capital for Facilities, Unused Prior Transfer to Capital (originated from either a project that was planned and approved that the district decided to forego, or project

was completed with surplus funds remaining), Transfer to School Lunch Fund and Transfer to Special Aid Fund (school's share of summer special education program costs for in district and out of district students, plus transportation; Capital Projects.

III. President Posterli called for Board of Education Comments

BOE Comments

- Board Member Vrona stated that, regarding insurance, there is little control over rate increases isn't that basically true to most of tonight's presentation (yes)? Thanked the Board Capital Projects subcommittee.
- Board Member Pinto thanked Mr. DeVito for including photos of capital projects so that the public could get a better understanding of them . Asked how State Aid would impact the 0.83 % tax increase. (If we get more state aid, allows us to use less of our savings, or expand program).
- Vice President Ryan if we have sufficient cyber insurance, and Mr. DeVito stated that some of the sublimits are too low, working on an application now to increase them. Would auditors be pleased (yes)? Dr. Ryan also asked for a breakdown of the legal costs, and asked if disciplinary hearings are down this year (yes, drastically).
- Board member Conway stated with addition of pickleboard courts, the middle school tennis courts can be used year round. Asked how STAR funding will effect the budget, and Mr. DeVito replied that the State gives the district money reduced by STAR exemptions. If the State stops STAR reimbursements, the community would have to make up the difference.
- Board Member Vrona stated the budget will be adopted at the April 13th Board meeting, and Board member Conway asked for an additional meeting to review the budget. Additional meeting will be on April 7th (work session). Mr. DeVito will have more information on State Aid at that time.

Because the funds to be expended hereunder are from the Capitol Reserve Fund, approval of this proposition will not require a tax levy upon the real property of the district."

- Board Member Conway asked about the • greenhouse construction, and Dr. Romanelli replied that construction should be under way after spring break.
- Board Member Conway asked for clarification regarding regents exams, and • Dr. Romanelli replied that the State is applying for a waiver from the SED and even if waiver not accepted, State will only be offering 4 regents exams this year-Algebra I, Living Environment, Earth Science and English. They would not be a requirement. Students who do take them will have option of having grade on transcript. Ms. Conway asked if that means that students don't have to take the regents if they don't want to? Dr. Gallagher said that's the way it looks at the moment, but reaching out to State for further clarification.
- Board Member Pinto asked how the CDC plan changes our plan? Dr. Gallagher replied that barriers are no longer required, trying to cancel the order, we are going to install what we do receive, reduces distance to 3', will still use barriers in cafeteria and other classrooms that require close contact, such as science labs. Social distancing requirement for musical instruments and chorus reduced to 6'. No impact on transportation.

Χ. Questions and Comments from the Public

- A member of the public stated why West and Lido are being asked to once again be the "late schools", starting at 9:35 and ending at 3:55, puts parents and teachers in a pinch. Why asking same 2 schools to have to do that again? Dr. Gallagher said reduces stress on transportation department. Driver shortage across Long Island. Agrees it is not ideal, and will revisit it. Not set in stone. This member of the public stated it was not transparent (not intentional). Dr. Gallagher stated that information should not have gone out, since it had not yet been finalized. Board Member Pinto wanted clarification, it is not a Covid issue, it is a transportation issue (Dr. Gallagher said yes).
- A member of the public reiterated that the late start schools put a financial • burden on parents - have to hire babysitters, etc.
