I. Superintendent's Opening Remarks/Call to Order

Board President Dr. Ryan called the regular meeting of the Board of Education to order at 7:00pm and led the public in the Pledge of Allegiance, and welcomed everyone back from the spring break. Dr. Ryan also stated that Mr. Pinto sends his regrets in being absent from tonight's meeting due to a death in the family.

II. Superintendent's Report – Dr. Gallagher

Superintendent's Report

Dr. Gallagher stated that tonight's Student Showcase was "No Place for Hate" and "Names, Not Numbers". Dr. Gallagher stated that both the high school and middle school have been designated as "No Place for Hate" schools. Dr. Gallagher also stated that, for the first time, our high school is engaged in a program called "Names, Not Numbers", a unique program where students interview holocaust survivors. Ms. Beard and Mr. Lewin introduced the middle school students involved in the "No Place for Hate" program. One project included the presentation of a book "I Am Human", a picture book on empathy. Mr. Noss, the advisor for the Anti-Bullying Club at the high school, introduced high school students involved in "No Place for Hate"; a student read the pledge taken by all students in the Anti-Bullying Club, and described various projects and events to bring awareness to tolerance and acceptance of all. Mr. Noss then introduced several high school students involved in "Names, Not Numbers" and their experiences in interviewing holocaust survivors.

Dr. Gallagher then introduced Mr. DeVito, who presented on Federal Grants, specifically, an update on American Rescue Plan Funding. Highlights of the use of the grant funds include In School and After School enrichment, student support by funding an Assistant Director of Special Education; student engagement, with Camp Intervention, Cold Spring Harbor Lab programs, Spaceflight Experiments, and Crew Team; Ventilation upgrades, repair of seven HVAC units in the high school; instructional support in the form of a fully enclosed greenhouse, elementary greenhouses, a plasma cutter and a CNC router.

The Presentation "American Rescue Plan Funding" is on the District Website and available in the office of the District Clerk.

III. President Ryan called for Board of Education Comments

- Board Member Pace stated how impressed she was by all who presented; loved the collaboration with other groups as well.
- Board Vice President Conway stated that she admires the students who spoke so eloquently and passionately.
- Board President Ryan stated that he was disappointed that there was nothing allocated in the grant for reading and math.
- Board member Vrona asked about the hiring of teachers in the grant, do they know
 they are being hired as "grant funded", and Dr. Gallagher replied that any teacher
 that is hired, there is always attrition, and that some teachers that move into the
 grant funded programs are long standing tenured teachers, who would move back
 to their previous positions if the programs expire.
- Board Member Pace feels that the grant funded initiatives treat the whole child, and sees much academics in the programs.
- Board Vice President Conway asked how many social workers are covered in this grant and Mr. DeVito replied one.

VI.2 Dr. Gallagher recommended the APPROVAL OF BUDGET TRANSFERS

A) BOCES EXPENDITURES

BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education approves a transfer in the amount of \$413,400.00 to the BOCES transportation code from the Special Ed T/A MS code to cover the cost of BOCES transportation services for the 2021-22 school year and a transfer in the amount of \$93,000.00 to the BOCES curriculum development code from the teacher elementary Lido code to cover the cost of BOCES curriculum development services for the 2021-22 school year.

Award of Bid – Tent Rental

WHEREAS, the District placed legal notice advertising a bid for Outdoor Tent Rental in the official district papers on March 10, 2022, and provided bid documents to Ace Party and Tent Rental; and

WHEREAS, the District, in accordance with Article 5-A of the General Municipal Law, invited bids on Outdoor Tent Rental which bids were opened publicly on March 11, 2022; and

WHEREAS, Ace Party and Tent Rental was the sole bidder on the Outdoor Tent Rental bid at a bid of \$65,057.00;

THEREFORE, BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby determines that Ace Party and Tent Rental was the lowest priced responsible bidder on the Outdoor Tent Rental bid and approves the award of the Outdoor Tent Rental contract to J Ace Party and Tent Rental, and authorizes the District Assistant Superintendent for Finance and Operations to execute said agreement on its behalf.
