I. Superintendent's Opening Remarks/Call to Order

Board President Dr. Ryan called the regular meeting of the Board of Education to order at 7:00pm and led the public in the Pledge of Allegiance.

II. Superintendent's Report - Dr. Gallagher

Superintendent's Report

Dr. Gallagher presented on the Strategic Planning Process. In explaining why the District develops a Strategic Plan, Dr. Gallagher stated that it defines what the District will look like in five years and how we will get there, aligns plans and strategies with community expectations and goals, and serves as a blueprint for change and a framework for decision-making. The District will use a continuous improvement model, with key areas to consider including achievement scores, program reviews, college entrance and completion rates, student engagement and attendance, etc. Dr. Gallagher went on to outline the timeline of the process steps; form steering committee in June 2022; committee will seek input from stakeholders Sept/Oct. 2022; committee compiles and analyzes feedback; committee finalizes a draft of the strategic plan in December; and, finally, the plan is presented to the Board in January 2022.

The "Long Beach Public Schools Strategic Planning Process Kick-off" presentation is on the District Website and available in the office of the District Clerk.

Dr. Gallagher then asked Julia Lang-Shapiro, Director of Media, Visual and Performing Arts, to present the Music and Art Awards recognition certificates for the 2022-23 school year. Ms. Lang-Shapiro announced that once again the district has been recognized as a Best Communities for Music Education. Musical performances by Ezra Hauser, 4th grade band at West School and Nathaniel Kaplan, 5th grade orchestra, also at West School. Jacob LoCascio, a high school senior, talked about his wonderful experiences in music and theatre throughout his time as a Long Beach student, particularly as an NYSSMA All State musician and his participation in Musicians Helping Musicians.
