I. Call to Order/Pledge/Opening Remarks - President Ryan President Ryan called the meeting to order at 7:30 PM, led the community in the Pledge of Allegiance and reported the progress of the superintendent search process.

Dr. Butera proudly noted that 2 Odyssey of the Minds teams are going to the World Championship; LB had award winners at the Locust Valley Film Festival; the anti-bullying club has been invited to local High Schools to present; and Dr. Passi received a First Place award from the National Association of Secondary Principals.

LONG BEACH K-12 SCIENCE PROGRAM – Presentation by Kenneth Graham

Mr. Graham reviewed the Mission Statement and Objectives, HS programs/competitions/research, Grade 8 Earth Science Opportunity and Success, Universally Accelerating 8th Grade, Living Environment, MS curriculum, Elementary Level Science Curriculum by Grade Level, Science Research, Professional Development and web site: Long Beach Science News and Events. Presentation is on file with the District Clerk.

Board of Education Comments

- President Ryan inquired about social sciences vs. physical sciences in competitions; asked about the concerns of the science department and the awareness of the guidance department to the programs/classes/options for students.
- Board Member Lester is encouraged by science program; expressed concerns about less challenging curriculum, passing grade and rates on Earth Science Regents, and expectations of success in MS vs. HS.
- Vice President Gallagher questioned Earth Science vs. Living Environment, the horizontal articulation with math department, the success/growth of the AP program and improvement of elementary school curriculum and labs.
- Board Member Guma asked about enrichment as part of elective schedule.
- Board Member Tangney commended Mr. Graham on the department, on the presentation, the teachers, and the direction of the science department.
